WHEREAS, Assignor is desirous of and willing to grant to Assignee its entire right, title, and interest in and to the Patents, the Trademarks, and the Other Intellectual Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, grants, transfers, and otherwise conveys to Assignee, *nunc pro tunc*, effective as of 24 January 2012, its entire right, title, and interest in and to the Patents, the inventions and technology set forth and described in the Patents, and any and all divisions, continuations, continuations-in-part, reissues, reexaminations, renewals, and extensions of the Intellectual Property (collectively "Patent Properties"). Such assignment expressly includes the right to sue for and collect past and future damages for patent infringement of the Patent Properties throughout the world. It is the intent of the Parties that such assignment of the entire right, title, and interest of the Patent Properties is to be held and enjoyed by Assignee for its own use and behoof, and for its successors, assigns, and legal representatives, as fully and entirely as the same would have been held by Assignor had this assignment and transfer not been made.

Assignor also hereby assigns, grants, transfers, and conveys to Assignee, *nunc pro tunc*, effective as of 24 January 2012, all right, title and interest in and to all Trademarks, including any and all common law trademarks owned by Assignor, regardless of whether they are specifically identified in Exhibit A (collectively "Trademark Properties"), together with the goodwill of the business symbolized by all of the Trademark Properties, including claims for damages by reason of past infringement of said Trademark Properties, with the right to sue and collect therefor.

Assignor further hereby assigns, grants, transfers, and conveys to Assignee, *nunc pro tunc*, effective as of 24 January 2012, all right, title and interest in and to the Other Intellectual Property, regardless of whether specifically identified in Exhibit A, and including any and all copyrights, regardless of whether registered or

unregistered, and domain names, including claims for damages by reason of past infringement of said Other Intellectual Property, with the right to sue and collect therefor.

Assignor represents and warrants that as of the Effective Date of this Assignment, it has the full right to convey the interests herein assigned and that it has not executed any agreement in conflict herewith.
