## ASSIGNMENT

WHEREAS, WE, **Jeffrey J. Vaitekunas**, a citizen of the United States, residing in Erie, PA, and **Emery S. Rose**, a citizen of the United States, residing in Manhasset, NY, (hereinafter referred to as "ASSIGNORS"), have invented **ULTRASONIC GENERATOR SYSTEMS AND METHODS** for which U.S. patent application Serial No. 14/037,096 was filed on September 25, 2013; and

ASSIGNORS HEREBY authorize and request the Director of the United States Patent and Trademark Office, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

ASSIGNORS HEREBY grant the firm of ULMER & BERNE LLP the power to insert in this Assignment any further identification or information which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.




