## INTELLECTUAL PROPERTY ASSIGNMENT

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign and transfer unto Assignee, its legal successors and permitted assigns all right, title and interest, whether statutory, registered or at common law, in and to the IP, together with the goodwill symbolized by them, throughout the world, and any renewals or extensions thereof.

Upon request of Assignee, Assignor covenants to execute and deliver to Assignee such further instruments of conveyance, transfer and confirmation and take such other action as Assignee may reasonably request from time to time on or after the date hereof, all without further consideration, in order to more effectively convey and transfer to Assignee said trademarks, and the registrations thereof, together with the goodwill of the portion of Assignor's business that is symbolized by said trademarks, and with all claims that could be asserted by Assignor arising out of or relating to the use or ownership of said trademarks.


In the event of any conflict or inconsistency between the terms, provisions and conditions of this Trademark Assignment and the Purchase Agreement, the terms, provisions and conditions of the Purchase Agreement shall govern.


This instrument shall be governed by the laws of the State of New York (without regard to conflicts of laws principles).


