EXCEPTION TO REQUIREMENT TO USE "LIMITED" IN NAME

The Australian Securities and Investments Commission pursuant to subsection 150(1) of the Corporations Act 2001 (the Act), hereby gives notice that:

**THE INSTITUTE FOR EYE RESEARCH
Australian Company Number 081 303 282**

(the company) has become registered as a company with limited liability without the addition of the word "Limited" in its name, subject to the requirements outlined under Section 150 of the Act.

Subsection 150(1) of the Act states that ASIC may register a limited by guarantee company without "Limited" in its name, or alter the registration of a company of that type by omitting "Limited" from its name, if its constitution:

- a) requires the company to pursue charitable purposes only and to apply its income in promoting those purposes; and
- b) prohibits the company making distributions to its members and paying fees to its directors; and
- c) requires the directors to approve all other payments the company makes to its directors.

Furthermore, subsection 150(2) of the Act requires that the company notify ASIC as soon as practicable if any of those requirements or prohibitions in its constitution are not complied with, or if its constitution is modified to remove any of those requirements or prohibitions.

ASIC may change a company's name so that it includes the word "Limited" by altering the details of the company's registration to reflect the change if the company contravenes any of the requirements or prohibitions in its constitution referred to in subsection 150(1); or the company modifies its constitution to remove any of these requirements or prohibitions.
