ASSIGNMENT AGREEMENT

- the right to sue for damages and other remedies and to otherwise enforce, and to keep any damage awards, royalties and other proceeds therefrom for itself, for any past, present and/or future infringement of any of the aforesaid Applications and Letters Patents of the United States;

AND the ASSIGNORS hereby authorize and request the Commissioner of Patents and Trademarks of the United States to issue any and all Letters Patents of the United States to the ASSIGNEE, its successors, and assigns;

AND the ASSIGNORS, each for itself or himself, hereby represents, warrants, covenants and agrees that collectively or severally they have the full right to convey the entire interest purported herein to be assigned, and that it or he has not executed, and will not execute, any agreement or other instrument in conflict herewith; provided, however, that any prior executed assignment by any of the above named inventors to Solvay Solexis or ASSIGNEE or obligation regarding same, is not in conflict herewith and is confirmed hereby;

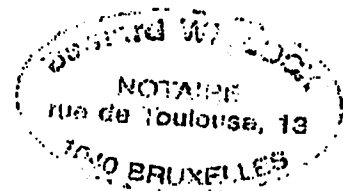
