
AND WHEREAS, at the time the improvements were made, I was under an obligation to assign all of my right, title, and interest in said improvements to Trackwise Designs Limited.

NOW THIS INDENTURE WITNESSETH, that for the sum of one dollar and other valuable consideration to me in hand paid, the receipt of which is hereby acknowledged, I hereby assign, sell, and transfer unto said Trackwise Designs Limited my entire right, title, and interest in said improvements, said applications, and all priority, divisional, continuing, substitute, renewal, reissue, and all other applications for Letters Patent which have been or shall be filed in the United States and all foreign countries on any of said improvements; and in and to all original and reissued patents which have been or shall be issued in the United States and all foreign countries on said improvements; and in and to any and all priority rights, rights under the International Convention For The Protection Of Industrial Property, rights under the Patent Cooperation Treaty, and other benefits accruing or to accrue to me with respect to the filing of applications for patents or securing of patents in the United States and countries foreign thereto.


And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said Trackwise Designs Limited as the assignee of my whole right, title, and interest thereto.
