of Intellectual Property Rights


Surgix Ltd. No. 513814558 (the "Company") hereby, undertakes, agrees, represents and warrants as follows:

In consideration for the consideration the receipt of which is hereby acknowledged, the Company does hereby sell, assign, transfer and set over unto **Orthopedic Navigation Ltd. 

The Company, hereby waives any claims that it, or anyone coming in its stead have, or shall have in the future, in connection with the Transferred Intellectual Property, any rights embodied therein or the sale thereof as set forth herein including without limitation any and all moral rights the Company may have in the Intellectual Property transferred and assigned hereunder.

The Company, hereby undertakes to sign and execute any and all documents (including affidavits) as may be required by the Buyer, in their sole discretion, for the performance of this agreement and the Company's obligations hereunder (including in connection with the transfer of the Transferred Intellectual Property and rights therein) and covenant without further compensation, to execute and deliver all documents required for transferring the Transferred Intellectual Property to the Buyer, to communicate to the Buyer all facts known to the Company with respect to the said Transferred Intellectual Property, whenever requested, to testify in any legal proceeding in which the IP may become involved, to sign all lawful papers, to make all rightful oaths, and to take any necessary action to aid the Buyer to register this assignment of the Transferred Intellectual Property for the consideration paid to the Company, the Company hereby covenants and agrees to and with the Buyer, that whenever their counsel or representative shall advise that formal application papers must be executed or an amendment to, or a division





