PATENT ASSIGNMENT AGREEMENT

THIS PATENT ASSIGNMENT AGREEMENT is made as of the 3rd day of September, 2014, by **Americast, Inc.**, a Virginia corporation with a place of business at 1020 Harris Street, Charlottesville, VA 22903 (the "Assignor").

Assignor is the owner of all right, title and interest in and to the patents set forth in Exhibit A (collectively, the "Patents").



The Assignor hereby authorizes and requests that all national governments and authorities that have issued the Patents to issue, record and memorialize this Assignment with regard to all of the Patents. Assignor agrees, upon reasonable request, without further payment or compensation by Assignee or its successors or assigns: to provide all further reasonable cooperation, including taking such further action and executing such additional documents, which Assignee, its successors and assigns reasonably determines is necessary to record and fully effect the transfer of patent rights made herein.


