BETWEEN

- (D) The parties hereto have agreed to execute this Deed to perfect the title of the Assignee in the invention and any and all patents granted in respect of the said patent applications.


NOW THIS DEED WITNESSETH AS FOLLOWS:

And in particular in regard to the said patent applications the Assignor will do all acts, execute all documents and procure the making of any declaration necessary or required by law and will comply with any other reasonable matter or thing in order to confirm permit

afford or facilitate the recordal of the Assignee's name as applicant of the said patent applications and to perfect title to any Letters Patent granted thereon in the name of the Assignee. And in case of default the Assignor hereby appoints the nominee of the Assignee Attorney to the Assignor for such purpose.


