Assignor agrees to assign and execute any and all other papers necessary or desirable for the procurement of Letters Patent on said Inventions in this and all foreign countries for the use of Assignee, said agreement surviving Assignor's employment by, or contract with, Assignee.

Assignor understand that Bingham Greenebaum Doll LLP does not personally represent Assignor or Assignor's legal interests, but instead represents the interests of Assignee. Assignor acknowledges its right to retain its own independent legal counsel.

If any provision of this Assignment shall be ruled invalid or unenforceable by a court of competent jurisdiction, that ruling shall not affect the validity or enforceability of the remaining provisions of this Assignment, which remaining provisions shall continue in full force and effect as if this Assignment had been executed with the invalid portion eliminated.
