ASSIGNMENT OF INVENTION

And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said **BAIDU ONLINE NETWORK TECHNOLOGY (BEIJING) CO., LTD.** as the assignee of the whole right, title, and interest thereto.
