**CONFIRMATORY PATENT ASSIGNMENT
OF PREVIOUS SIDEL HYDRAPAK IP**

This CONFIRMATORY PATENT ASSIGNMENT, dated as of this 6th day of March, 2014, is made by and between:

Sidel Participations, S.A.S., a company organized and existing under the laws of France, having its main office at Avenue de la Patrouille de France, F-76930 Octeville-sur-mer, France, ("Sidel"), and

DISCMA AG, a company organized and existing under the laws of Switzerland, having its main office at c/o SIDEL INTERNATIONAL AG Bösch 67, 6331 Hünenberg / ZG, Switzerland, (the "Company").

Sidel and the Company shall collectively be referred to herein as the "Parties", and individually as a "Party".

WITNESSETH

WHEREAS, pursuant to the Previous Sidel Hydrapak IP Assignment Agreement between the Parties and dated the 6th day of March, 2014, Sidel did assign, transfer and convey to Company and Company accepted, all of Sidel's right, title and interest in and to the Previous Sidel Hydrapak IP, including but not limited to the patent applications identified in Table I;

NOW, THEREFORE, for the good and valuable consideration set forth in the Previous Sidel Hydrapak IP Assignment Agreement, the sufficiency of which is hereby acknowledged, Sidel hereby confirms and agrees as follows:

1. Sidel hereby confirms its assignment, transfer and conveyance, to Company, and Company hereby confirms its acceptance thereof, of all of Sidel's right, title, and interest in and to the Previous Sidel Hydrapak IP identified in Table I, including the right to claim priority under the Paris Convention, all causes of action and enforcement rights, whether currently pending, filed or otherwise, all rights to pursue damages, injunctive relief and other remedies for past, current and future infringement, and all rights to collect royalties, including royalties for past infringement, under such Improved Hydrapak IP;

2. The Previous Sidel Hydrapak IP includes all right, title and interest in and to the patent applications identified in Table I below, including any patents that may be granted anywhere in the world originating from or claiming priority to said patent applications, including any divisionals, continuations, reissues, substitutions, extensions and renewals thereof, and further includes all right, title and interest in and to any inventions claimed or described in said patent applications.


