required to be done for the maintenance, enforcement and defense of said Letters Patent, whenever Assignee shall advise.

Assignor authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as owner of said Letters Patent.

This Assignment may be executed in any number of counterparts and by the separate parties on separate counterparts, each of which when executed and delivered shall constitute an original, and all such counterparts together shall constitute but one and the same Agreement.



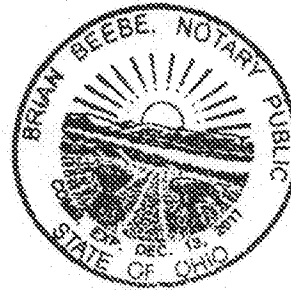
