Today, the twenty-ninth of

June two thousand and four, appeared before me,

Cornelia Holdinga, civil-law notary in Amsterdam:

Silvia Rahel Catharina Tegeler, care of Strawinskylaan 2001, 1077 ZZ Amsterdam, born in Bant on the sixteenth day of December nineteen hundred and seventy.

The appearing person declared:

- that the articles of association of the company with limited liability (*besloten vennootschap met beperkte aansprakelijkheid*) Pharmacia Groningen B.V., having its seat in Groningen, its address at 9728 NX Groningen, Van Swietenlaan 5, filed at the Trade Register under number 02032828, (the 'company'), were lastly amended by deed executed on the ninth day of June two thousand and four before G.C. van Eck, civil-law notary in Rotterdam, in respect of which amendment the Minister of Justice has advised on the twenty-sixth day of May two thousand and four under number B.V. 150081 that no objections have become apparent;
- that the shareholders meeting of the company has decided to amend the articles of association of the company partially;
- that furthermore, it was decided to authorize the appearing person, to enable him to effect the amendment to the articles of association;
- that such resolutions are evidenced by a written shareholders resolution to be attached to this deed.

Subsequently, the appearing person declared to amend the articles of association of the company partially, in pursuance of the referred resolutions, so they read as follows:

**Article 1 paragraph 1 will read as follows:**

1. The name of the company is: AMO Groningen B.V.

**Final statement**

Finally the appearing person declared that the Minister of Justice has, evidenced by the statement to be attached to this deed advised on the twenty-sixth day of June two thou-

sand and four under number B.V. 150081 that in respect of the current amendment to the articles of association no objections have become apparent.

This deed was executed today in Amsterdam.

The substance of this deed was stated and explained to the appearing person.

The appearing person declared not to require a full reading of the deed, to have taken note of the contents of this deed and to consent to it.

Subsequently, this deed was read out in a limited form, and immediately thereafter signed by the appearing person and myself, civil-law notary, at eleven hours ninety-five minutes ante meridiem.
