c) "Invention" means an invention made by the Assignors and entitled, **HANDLE FOR LUGGAGE** and having Application No. **61/407,971**, filed **October 29, 2010**.

d) "Rights to the Invention" means, without limitation, all rights, titles, interests and claims of any nature in and to:

- i) the Invention for Canada, the United States of America and all other foreign jurisdictions;
- ii) all Patent Applications for the Invention for Canada, the United States of America and all other foreign jurisdictions ("Patent Applications");
- iii) all Letters Patent that may be obtained for the Patent Applications ("Issued Patents");


