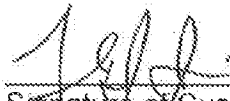

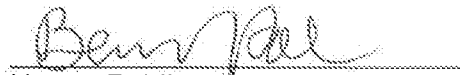

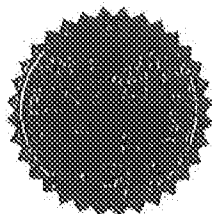

SECOND The Corporation's Amended Certificate of Incorporation, is hereby amended by amending Article I thereof to read in its entirety as follows:

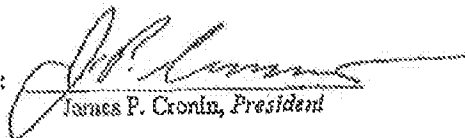
1. The name of the corporation is Cytex Surface Specialties Inc.

**RESOLVED,** that the President or any Vice President of CII be and each of them

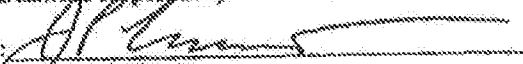

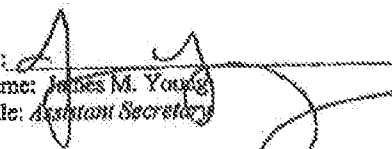
