I HEREBY authorize and request the Director of the United States Patent Office and all offices of the country, whose duty is to issue patents, to issue Letters Patent to the Assignee, as assignee of the whole right, title and interest thereto;

I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

I FURTHER agree to execute all necessary and lawful documents, including without limitation, assignments in favor of Assignee or its Assignees, declarations, applications, divisions, continuations and continuations-in-part, reissues, or other documents which Assignee may from time-to-time present to me in order to perfect title in the Inventions, modifications, and improvements in the Inventions, Patent Applications, and Letters Patent of the United States and countries foreign thereto;

AND I HEREBY further covenant and agree that I will communicate to Assignee any facts known to me respecting the Inventions, and testify in any legal proceeding, and generally do everything possible to aid Assignee to obtain and enforce patent protection for the Inventions in all countries.

This Assignment may be executed in counterparts.


