for which an application for Design Letters Patent of the United States of America was filed on September 16, 2014, as **U.S. Serial No. 29/502,431**.



The ASSIGNORS hereby authorize and request the Commissioner of Patents and Trademarks to issue said Design Letters Patent which may be granted for said invention to the ASSIGNEE as the assignee of the entire right, title and interest therein.




