NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, Assignors hereby sell, assign, and set over to Assignee their entire rights, titles and interest in and for the United States of America and all other countries in and to said invention and the aforesaid application, all original, divisional, continuation, continuation-in-part, substitute or reissue applications and patents applied for or granted therefor or therefrom in the United States of America and all other countries, and the Commissioner of Patents and Trademarks is hereby authorized and requested to issue all patents on said application and/or applications resulting therefrom to Assignee; and the undersigned for them and their legal representatives, heirs and assigns do hereby agree and covenant, without further remuneration, to execute and deliver all divisional, continuation, continuation-in-part, reissue and other applications for Letters Patent on said invention and all assignments thereof to Assignee or its assigns, to communicate to said Assignee or its legal representatives all facts known to the undersigned respecting said invention, to testify in any interferences or other legal proceedings in which any of said applications or patents may become involved, to sign all lawful papers, make all rightful oaths and to do generally everything necessary to aid Assignee, its successors, assigns and nominees in obtaining patent protection on said invention to all countries, the expenses incident to said applications to be borne and paid by Assignee.
