(iii) any other remedies of any kind for past, current, and future infringement.

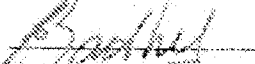
2. ASSIGNEE has by written agreement accepted, and insofar as necessary herewith accepts, this assignment and transferral with all rights and obligations.

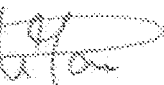

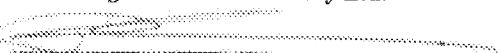

JUDGMENT

DISTRICT COURT THE HAGUE

Team insolvencies – single-judge section

petition number : C/09/456392 / FT EA 13/626

SALUSION IP B.V.,
petitioner,

has filed a petition for adjudication of its own bankruptcy.

Petitioner has been heard in chambers.

The district court, having regard to the provisions of Article 3 paragraph 1 Regulation 1346/2000 of the Council of the European Union, has jurisdiction to open these insolvency proceedings as main proceedings now that the centre of petitioner's main interests is situated in the Netherlands.

During the hearing in chambers, prima facie evidence was shown of the existence of facts or circumstances that demonstrate that the petitioner is in a state of having ceased to pay. Accordingly, the bankruptcy is to be ordered.

DECISION
