ASSIGNMENT

THIS ASSIGNMENT AGREEMENT is effective as of February 27, 2012, and is between

(i) Bay Materials LLC, a corporation organized and existing under the laws of the State of California, U.S.A., having a place of business at 3700 Haven Court, Menlo Park, CA 94025-1043 USA (hereinafter BAY MATERIALS) , and (ii) Ray F Stewart, a citizen of the United States, of 807 Toyon Way, Redwood City, CA 94062, USA (hereinafter STEWART) .

WHEREAS


BAY MATERIALS and STEWART have agreed as follows.

1. STEWART, insofar as he has not already assigned to BAY MATERIALS all his right, title and interest in INVENTION, does, in consideration of the sum of \$1.00 and other good and valuable consideration, the receipt of which is hereby acknowledged, hereby assign to BAY MATERIALS, and BAY MATERIALS accepts, his entire right, title and interest in INVENTION, including, but not limited to, any and all applications, including but not limited to, the applications listed above and any continuation, continuation-in-part, divisional and reissue applications, for Letters Patent, Utility Models and other Proprietary Rights throughout the world for INVENTION, all Priority Rights for INVENTION derived from such applications under International Conventions or otherwise throughout the world, and any and all Letters Patent granted on said applications.

2. STEWART covenants that he has the full right to convey the right, title and interest herein assigned, and has not executed, and will not execute, any agreement in conflict herewith.

3. STEWART covenants that he will communicate to BAY MATERIALS any facts known to him concerning INVENTION, and will, at the expense of BAY MATERIALS, testify in any legal proceedings concerning INVENTION, sign any lawful paper, and generally do everything possible to assist BAY MATERIALS in obtaining and enforcing Letters Patent, Utility Models, and other Proprietary Rights for INVENTION throughout the world.
