**WHEREAS, I, Li Sun, ~~7777 Greenbriar, Apt. 3100, Houston, TX 77030~~**, United States of America, have invented certain new and useful improvements in "**SOLUTION BASED POLYMER NANOFILLER-COMPOSITES SYNTHESIS**" for which a non-provisional application was filed on May 9, 2014 under Serial Number 14/274,111, and for which a PCT application was filed on May 9, 2014 under Serial Number PCT/US2014/037480;
