Brush & Co., Inc.**, its successors, legal representatives, and assigns, in accordance with the terms of this instrument.

And I hereby covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

And I hereby further covenant and agree that I will communicate to said **John D. Brush & Co., Inc.**, its successors, legal representatives, and assigns, any fact known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all non-provisional, divisional, renewal, substitutional, continuation, and reissue applications, make all rightful declarations and/or oaths and generally do everything

possible to aid said John D. Brush & Co., Inc., its successors, legal representatives, and assigns, to obtain and enforce proper patent protection for said invention in all countries.




