NOW, THEREFORE, in consideration of the of sum of [REDACTED] and the compensation now and hereafter paid to Assignor by Assignee, receipt of which is acknowledged, Assignor does hereby assigns, transfers, and conveys to Assignee (which term shall include Assignee's successors, Assignee's legal representatives, and assigns), full and entire rights, title and interest in and to any and all Inventions, all improvements therein, the Applications and all priority rights arising anywhere in the world therefrom, and any patents, divisionals, reissues, reexaminations, and extensions thereof, which issue in any country upon any patent applications which correspond with any of the following: the Application, any divisionals, reissues, reexaminations, continuations-in-whole, or substitute United States or foreign applications which is based on the Application; or any continuations-in-part United States applications or foreign applications (including divisions, continuations-in-whole or -in-part, and substitutions thereof or therefor) based in-part on any of the above described applications. Assignor agrees that all such interest as described above are the sole property of the Assignee.

Each Assignor further agrees that each Assignor will assist the Assignee in every proper way to enforce United States and Foreign Proprietary rights relating to Assignee's Inventions in any and all countries. To that end, each Assignor and Assignor's heirs, executors, administrators, legal representatives will, without further consideration, cooperate with Assignee in the prosecution of all of the above applications, execute, verify, acknowledge and deliver all such further papers, including applications for patents, patents, continuations, continuation-in-part, divisionals, renewals or substitute, reexamination, reissues and extensions therefor, and instruments of assignment and transfer thereof, and will communicate any facts known to Assignor relating to the Invention, to obtain or maintain or enforce patents for the Invention and improvements therein in any and all countries and to vest title thereto in Assignee.


Each Assignor further agrees that such Assignor will, without further compensation to Assignor during the term of any employment by Assignee and thereafter for reasonable compensation as determined by Assignee, perform such other acts as may be reasonably required when requested by Assignee, including attending depositions, preparing and executing declarations and affidavits and testifying as a witness, to obtain or maintain or enforce patents for the Invention and improvements therein in any and all countries and to vest title thereto in Assignee.
