- (iii) the right to take action and recover in respect of any infringement of the Patents that took place prior to the date of this Assignment.

The Assignor hereby irrevocably designates and appoints the Assignee and its duly authorized officers and agents as the Assignor's agent and attorney in fact, to act for and on the Assignor's behalf and stead, to do all such lawful acts and things and to execute such further lawful assignments, documents, assurances, applications and other instruments as reasonably may be required by the Assignee, its successors, assigns or legal representatives, to obtain any and all registrations for the Patents and to vest the same in the Assignee, its successors, assigns or legal representatives.
