THIS DEED is dated 27 August 2010

**BETWEEN**

- (1) **SEMBLANT LIMITED**, a company incorporated under the laws of England and Wales and having its registered office at 5<sup>th</sup> Floor, Liscartan House, 127-131 Sloane Street, London SW1X 9AS, United Kingdom (hereinafter called "**Semblant**" which expression where the context so allows shall include its successors and assigns); and
- (2) **SEMBLANT GLOBAL LIMITED**, a company incorporated under the laws of England and Wales and having its registered office at 5<sup>th</sup> Floor, Liscartan House, 127-131 Sloane Street, London SW1X 9AS, United Kingdom (hereinafter called "**Global**" which expression where the context so allows shall include its successors and assigns).

**BACKGROUND**

- (A) Semblant has agreed to assign to Global the patents and patent applications listed in the Schedule to this deed (the "**Patents**") on the terms set out in this deed.

**AGREED TERMS**

1. Semblant assigns to Global all of its right, title, share and interest in and to the Patents and the inventions which are the subject of the Patents ("**Inventions**") together with all rights in respect of all patents granted in respect of the Patents and Inventions together with the full and exclusive benefit thereof and all rights of action and powers accruing or belonging to Semblant. The assigned rights shall include the full right to apply for and obtain a patent or patents or other similar forms of protection in respect in the United Kingdom and all other countries of the world in the name of Global alone or as Global may from time to time otherwise elect or the relevant law may require including the benefit of any priority date and the right to make applications whether under any national law or under the International Convention for the Protection of Industrial Property or under any other applicable convention or treaty.
2. Semblant agrees that at any time hereafter and from time to time at the request and expense of Global it shall promptly execute and sign all such instruments applications and documents and do all such acts and things as may be required by Global to enable Global to enjoy the full benefit of the rights set out or assigned by this deed, including applying for and obtaining a patent or patents or other similar forms of

protection in respect of the Inventions in the United Kingdom and in all other countries of the world and vesting the same in Global or its nominees when obtained.


3. This document shall be governed by and construed in accordance with English law

This deed has been executed and delivered by the parties on the date first written above.






