## ASSIGNMENT

Paul R. Holbrook of Old Saybrook, Connecticut have invented certain new and useful improvements related to "Multi-ring plastic storage tanks and risers" as described in a U.S. patent application bearing such title and Atty. Paul R. Holbrook further agrees on behalf of himself, his successors, heirs and assigns, that upon request of the assignee and without any further payment or compensation, to communicate to the assignee any facts relating to said invention including evidence for interference purposes or other legal proceedings, to testify in any interference or other legal proceedings, to execute and deliver all lawful papers, and generally to do everything possible to aid the assignee to obtain and enforce patent protection for said invention in the USA or any foreign country.

Paul R. Holbrook as named inventor hereby declares: He is the original inventor of a claimed invention in the application; and, he hereby acknowledges that any willful false statement made in this declaration is punishable under 13 U.S.C. 1001 by fine or imprisonment of not more than five (5) years, or both.
