applications, make all rightful oaths, and do everything possible to aid Taylor Made Golf Company, Inc., its successors and assigns to obtain and enforce proper patent protection for said invention in this or any foreign country.



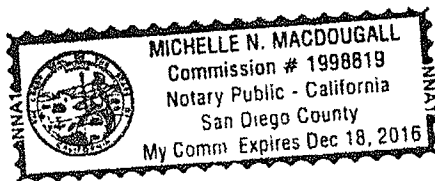
