WHEREAS, the PCT Application is properly entitled "Methods and Apparatus for Classifying Content" and should not been included in the list of Excluded Assets, but rather is included in the assets that the Assignor distributed, assigned, transferred, and/or delivered to the Assignee;

WHEREAS, by way of the Distribution and Transfer Agreement, the Assignor distributed, assigned, transferred, and/or delivered to the Assignee the Assignor's entire right, title and interest in the subject matter and invention(s) disclosed in the application(s) for patent and/or patent(s) identified in Schedule A;

NOW, THEREFORE, for good and sufficient consideration, the receipt of which is hereby acknowledged, and to the extent that the Assignor has not done so already via any prior agreement(s) with the Assignee, which includes at least the Distribution and Transfer Agreements, or if the Assignor has already done so via said prior agreement(s) with the Assignee then in confirmation of any obligation to do so in said prior agreement(s), the Assignor has sold, assigned, transferred, and set over, and by these presents does sell, assign, transfer, and set over, unto the Assignee, its successors, legal representatives, and assigns their entire right, title, and interest in and to said invention(s), said application(s), and said patent(s), the right to file applications on said invention(s), their entire right, title and interest in and to any applications for Letters Patent of the United States or other countries claiming priority to said application(s), including divisions, continuations, and continuations-in-part of said application(s), their right to recover damages, including provisional or other royalties, for prior infringements of said application(s) and said patent(s), their entire right, title and interest in and to any and all Letters Patent or Patents, United States or foreign, to be obtained for said invention(s) and said application(s), their entire right, title and interest in and to any and all reissues and extensions of said patent(s), and all rights under the Hague Convention, the Paris Convention for the Protection of Industrial Property, and under the Patent Cooperation Treaty, the same to be held and enjoyed by the Assignee, for its own use and behalf and the use and behalf of its successors, legal representatives, and

assigns, to the full end of the term or terms for which Letters Patent or Patents may be granted as fully and entirely as the same would have been held and enjoyed by the Assignor had this sale and assignment not been made;

AND for the same consideration, the Assignor hereby covenants and agrees to and with the Assignee, its successors, legal representatives, and assigns that the Assignor will, whenever counsel of the Assignee, or the counsel of its successors, legal representatives, and assigns, shall advise that any proceeding in connection with said invention(s), said application(s), said patent(s), any application claiming priority to said application(s), any reissue or extension of said patent(s), and any United States or foreign Letters Patent or Patents for said invention(s) or said application(s), including interference proceedings, is lawful and desirable, sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of Letters Patent or Patents for said invention(s), without charge to the Assignee, its successors, legal representatives, and assigns, but at the cost and expense of the Assignee, its successors, legal representatives, and assigns;

AND the Assignor hereby requests the Commissioner of Patents to issue any and all aforementioned patent(s) of the United States to the Assignee, as the Assignee of said invention(s) and the Letters Patent to be issued thereon for the sole use and behalf of the Assignee, its successors, legal representatives, and assigns.

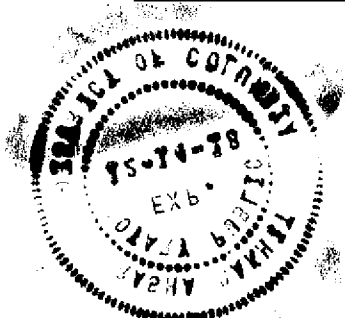

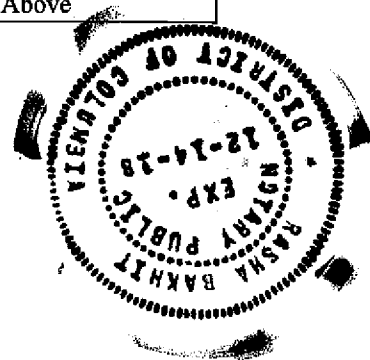
