
And PROCESS4 hereby authorizes Assignee to make applications for and to receive Letters Patent for said invention in any foreign countries in its own name, or in our name, at its election.

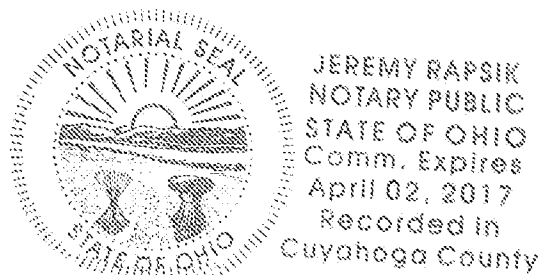
