## PATENT ASSIGNMENT

- (4) The right to apply for patents in foreign countries in its own name and to claim any priority rights to which such foreign applications are entitled under international conventions, treaties or otherwise.
- (5) The right to any and all claims and courses of action and other relief for past and future infringements and all proceeds thereof with regard to any of the foregoing.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue to Assignee any Patents which may be granted in accordance with this Assignment.
