ASSIGNMENT

Assignor further sells and transfers to Assignee, its lawful successors and assigns, Assignor's entire rights and interests to sue any and all alleged infringers for past, present, and future infringement of the '076 Patent in the United States and its territorial possessions. Assignor further agrees that all necessary records of Assignor to establish priority of invention in any interference or similar proceeding will be made available at no additional charge to Assignee, in the event such records are needed in connection with any of the assigned Patents.

2. Further Assurances. Assignor agrees without any additional consideration therefor to sign all documents, execute all reissue or other applications, make all assignments and rightful oaths, and generally do everything possible to aid Assignee, its successors, assigns, and nominees, to obtain and enforce proper protection for all said Patents in all applicable countries throughout the world.

3. Recordings. An executed copy of this Agreement may be filed with the United States Patent and Trademark Office or in the patent office of any other country or region, as applicable, by Assignee or Assignor at any time.


