ASSIGNMENT AGREEMENT

THIS ASSIGNMENT is dated 13 May 2013 ("Effective Date") and is made the 13th day of May 2013.

BETWEEN:

- (1) PATRICK YI, residing at 1509 Lemon Ave, Walnut, CA 91789, United States of America ("the Assignor");

AND

- (2) MEDIPURPOSE PTE LTD., a company incorporated in Singapore and residing at 15 Hoe Chiang Road, #12-02 Tower Fifteen, Singapore 089316 ("the Assignee")

(each, a "Party", and collectively, the "Parties").

BACKGROUND:

- (A) The Assignor has invented certain new and useful improvements in A Lancet for which a Singapore patent application no: 201202916-1 has been filed on 20 April 2012 in the name of the Assignee and naming the Assignor as inventor ("Invention").
- (B) The Assignor has agreed to assign to the Assignee, and the Assignee is desirous of acquiring all the rights, title and interest held by or attributed to him in and to the Invention, and in and to any Patents that may be obtained therefor.

IT IS AGREED as follows:

1. ASSIGNMENT

1.1 In consideration of the sum of Singapore One Dollars (S\$1) paid to the Assignor by the Assignee, the receipt of which is hereby acknowledged, and other good and valuable consideration, the Assignor hereby sells, assigns and transfers to the Assignee, its successors, assigns and legal representatives, as of the Effective Date, the full and exclusive right to the said Invention in Singapore and throughout the entire world and the entire right, title and interest in and to any and all Letters Patent(s) which may be granted therefor in Singapore and elsewhere in the world, and to any and all divisions, reissues, continuations, conversions and extensions thereof for the full term or terms for which the same may be granted.

1.2 The Assignor agrees, without demand for additional payment:

- (a) to execute all documents necessary in connection with any patent application for the Invention, and any continuing, divisional, conversion or reissue applications thereof and also to execute separate

assignments in connection with such applications as the Assignee may deem necessary or expedient;

- (b) to execute all documents necessary in connection with any interference which may be declared concerning any application or continuation, division, conversion or reissue or Letter Patent(s) or reissue patent issued in respect of the Invention and to cooperate with the Assignee in every way possible in obtaining and producing evidence and proceeding with such interference;
- (c) to perform all affirmative acts which may be necessary to obtain a grant of valid patent(s) for the Invention in the name of the Assignee and to vest all rights therein conveyed to the Assignee by this Assignment, as fully and entirely as the same would have been held by the Assignor if this Assignment had not been made.

1.3 The Assignor hereby authorises and requests the Patent and Trademark Offices in all countries in the world to issue any and all Letters Patents resulting from any patent application for the Invention or any continuing, divisional conversion or reissue applications thereof to the Assignee, as the assignee of the entire interest.

1.4 The Assignor warrants that:

- (a) he has the full right to convey the entire interest herein assigned; and
- (b) that he has not executed, and will not execute, any agreement in conflict with this Assignment.




2. ENTIRE AGREEMENT




