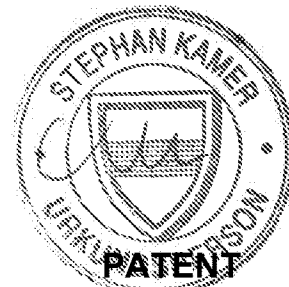
ASSIGNMENT OF UNITED STATES PATENT


and collect same for its own use and behoof, and for the use and behoof of its successors, assigns, or other legal representatives.


