ASSIGNMENT

WHEREAS, we, Michael A. NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and for other good and valuable consideration, the receipt of which is hereby acknowledged, we hereby sell, assign, transfer and set over to ASSIGNEE, all right, title and interest in and to said Inventions throughout the world, and said Application, and any and all regular and other patent applications claiming priority thereto, divisions, continuations, continuations-in-part and reissues thereof, and any and all patents of the United States and foreign countries which may be granted therefor, the same to be held and enjoyed by ASSIGNEE for its own use and benefit, and for the use and benefit of its successors, assigns, or other legal representatives, to the end of the term or terms for which said patents of the United States or foreign countries are or may be granted or reissued, as fully and entirely as the same would have been held and enjoyed by us if this assignment and sale had not been made.

And we hereby authorize and request the Commissioner of Patents and Trademarks and other authorities in foreign countries to issue any and all patents on said Inventions or resulting from said Application and from any and all related regular and other patent applications, divisions, continuations, continuations-in-part, and reissues thereof, to ASSIGNEE, as assignee of our entire interest, and hereby covenant that we have the full right to convey the entire interest herein assigned, and that we have not executed and will not execute any agreement in conflict herewith.

And we further hereby covenant and agree that we will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of the Inventions, Application and patents as may be granted therefor, to ASSIGNEE, its successors, assigns, or other legal representatives and that if ASSIGNEE, its successors, assigns or other legal representatives shall desire to file any related regular, divisional, continuation, continuation-in-part applications or other patent applications or to secure a reissue of such patents, or to file a disclaimer relating thereto, we will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing of such applications, and the procuring

thereof, and for the filing of such disclaimer, without further compensation but at the expense of said assignee, its successors or other legal representatives.

And we do further covenant and agree that we will, at any time upon request, communicate to **ASSIGNEE**, its successors, assigns or other legal representatives, such facts relating to said inventions and patents or the file history thereof as may be known to me, and testify as to the same in any interference or other proceeding or litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.
