ASSIGNMENT



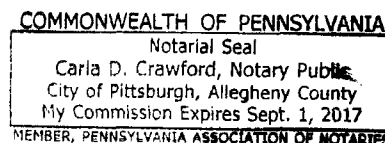

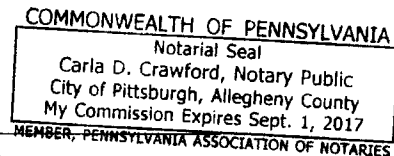
