## AGREEMENT REGARDING ASSIGNMENT OF PATENTS

THIS AGREEMENT REGARDING ASSIGNMENT OF PATENTS is made as of September 24, 2012, by THOMAS L. OWENS ("**Owens**"), WEST MOUNTAINVIEW INTERNATIONAL LLC, a Washington limited liability company ("**WMVI**"), JOHN S. FUJII ("**Fujii**") and TRUSSCORE SPECIALTIES LLC, a Washington limited liability company ("**TCS**"). Owens, WMVI and Fujii are collectively called the "**Assignors**."

### RECITALS

A. Owens is the inventor of the inventions embodied in and the sole owner of the patents listed on **Exhibit A** attached hereto and incorporated herein by this reference, and all related foreign patents and patent applications (collectively, the "**Patents**").

B. Fujii is the inventor of the inventions embodied in the patent applications and patents listed on **Exhibit B** attached hereto and incorporated herein by reference (collectively, the "**Fujii Patents**"). Fujii has previously assigned all of his interest in and to the Fujii Patents to WMVI, but has not registered such assignment with the U.S. Patent and Trademark Office ("**PTO**") or any other patent office.

C. Assignors desire to transfer and assign to TCS, and TCS desires to accept the transfer and assignment of, all of Assignors' worldwide right, title and interest in, to and under the Patents.

### AGREEMENTS

The parties hereto hereby agree as follows:

1. **Assignment.** Owens and Fujii will assign, transfer, grant and convey to TCS, and TCS will accept such assignments and transfers of, all worldwide right, title and interest of Owens and Fujii in, to and under the Owens Patents and Fujii Patents, respectively, and the inventions embodied therein, in form and substance as agreed by Owens, Fujii and TCS. WMVI hereby assigns and transfers to TCS all of WMVI's worldwide right, title and interest in, to and under the Patents and the inventions embodied therein.

2. **Consideration.** In exchange for the Owens Patents, TCS will issue to Owens 200,000 Units in TCS, as reflected in the Amended and Restated Operating Agreement of TCS dated as of 10 OCTOBER, 2012 (the "**Amended TCS Operating Agreement**"). In exchange for the Fujii Patents, TCS will issue to WMVI 200,000 Units in TCS, as reflected in the Amended TCS Operating Agreement. Such Units in TCS shall automatically be deemed issued to Owens and WMVI, respectively, upon the execution of the Amended TCS Operating Agreement by all parties.

3. **Representations.** Owens represents to TCS that he is the sole owner of the Owens Patents and that upon his assignment thereof to TCS pursuant hereto, TCS will own all right, title and interest in, to and under the Owens Patents. Fujii and WMVI jointly and severally represent to TCS that Fujii is the record owner of the Fujii Patents and WMVI is the sole beneficial owner of the Fujii Patents and that upon the execution hereof by WMVI and the assignment of his rights in the Fujii Patents to TCS pursuant hereto, TCS will own all right, title and interest in, to and under the Fujii Patents.

4. **Governing Law.** Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in

accordance with the laws of the State of Washington without giving effect to the principles of conflicts of laws thereof.


