## ASSIGNMENT

WHEREAS We, **PETER DUTTENHOEFER, STEFAN BLENKE**, residing respectively at Ilbesheim and Landau/Pfalz, Germany, have invented certain new and useful improvements in a

**TUBULAR LINER HAVING AN OUTER TUBULAR FILM CONNECTED IN AN OVERLAPPING MANNER BY ADHESIVE TAPE, FOR LINING PIPELINES, AND METHOD FOR MANUFACTURING SAME**

AND WE hereby authorize the said civil-law partnership to make an application for Letters Patent and the Director to issue any and all Letters Patent of the United States on the invention or resulting from the application and from any and all divisions and continuations thereof to the said civil-law partnership as the assignee of the entire right, title and interest in and to the same.
