RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST dated as of October 15, 2014 (this "Release") is made by Hercules Technology Growth Capital, Inc., a Maryland corporation (the "Lender"), and relates to that certain Intellectual Property Security Agreement, dated as of February 17, 2012, and recorded in the records of the United States Patent and Trademark Office, at Reel 027727/Frame 0340, and Reel 4719/Frame 0637 (as amended, supplemented or modified and in effect prior to the date hereof, the "Security Agreement"), between Wavemarket, Inc., a Delaware corporation (the "Company"), and Lender. Capitalized terms used (but not defined) herein are used as defined in the Security Agreement.

W I T N E S S E T H:

WHEREAS, pursuant to the Security Agreement which were recorded in the records of the United States Patent and Trademark Office, the Company granted to Lender a security interest in the Intellectual Property Collateral (as defined in the Security Agreement) including those set forth on Schedule I attached hereto (collectively, the "Collateral"); and

WHEREAS, the Lender wishes to: (i) terminate the Security Agreement and the Loan Agreement (as defined in the Security Agreement) against or covering the Collateral; (ii) release its lien on and security interest in the Collateral; (iii) restore all right, title and interest in, to and under the Collateral to the Company; and (iv) dissolve any and all liens and encumbrances granted to it by the Company respecting the Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender does hereby (i) terminate the Security Agreement and the Loan Agreement against or covering the Collateral, (ii) release its lien on and security interest in the Collateral, (iii) discharge, quit claim and relinquish unto the Company (in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in, to and under the Collateral and the lien and security interest granted to the Lender in the Collateral, and (iv) dissolve any and all liens and encumbrances granted to it by the Company respecting the Collateral.

Lender authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Release.

At the Company's expense, Lender shall take all further actions, and provide to Company, its successors, assigns or other legal representatives all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Company to more fully and effectively effectuate the purposes of this Release.
