ASSIGNMENT

WHEREAS, we, Hilde ANGELFOSS of Ålesund, Norway; Hans-Cato SLOTTERØY of Ålesund, Norway; Alf Vegard FJELLAND of Ålesund, Norway; Eivind HALSETH of Ålesund, Norway; and Oscar JOHANSEN of Ålesund, Norway have invented certain improvements in a STROLLER, for which we filed U.S. Design Patent Application Serial No. 29/498,465 on August 4, 2014; and

WHEREAS, Stokke AS, a Norwegian corporation, having its principal place of business in Ålesund, Norway, is desirous of acquiring an interest therein;

We hereby authorize and request the Patent Office officials in the United States and any and all foreign countries to issue any and all of said Letters Patent, when granted, to Stokke AS, as the assignee of our entire right, title, and interest in and to the same, for the sole use of Stokke AS, and its successors and assigns.

Further, we hereby covenant and agree to and with Stokke AS, and its successors and assigns, at the time of execution and delivery of these presents, that we are the sole and lawful owners of the entire right, title, and interest in and to the invention and the above-identified patent application, and that the same are unencumbered, and that we have good and full right and lawful authority to sell and convey the same in the manner herein set forth.

Further, we agree that we will communicate to STokke AS, or its representatives, any facts known to us respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to Stokke AS, make all rightful oaths, and generally do everything possible to aid Stokke AS, and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.




