AND WHEREAS the Assignor is willing to sell, assign, transfer and convey such rights unto Assignee for the said Trade-marks and Industrial Designs;



THE Assignor hereby further agrees, undertakes and covenants that they will sign or execute such further documents, assurances, applications, instruments or any other writing that may be requested by the Assignee or their legal representatives for the purpose of obtaining or registering any Trade-marks and Industrial Designs therein in order that all of their right, title and interest in the same may be vested in the Assignee, its successor and assigns.
