NOW, THEREFORE, for and in consideration of the terms of the prior agreements between the parties, and of other good and valuable consideration, the receipt of which is hereby acknowledged, the INVENTORS, Smart Design, Key Technologies and Flextronics Design (collectively, the "Hired Parties") confirm that they have sold, assigned and transferred and by these presents do hereby sell, assign and transfer unto said ASSIGNEE, its successors, assigns and legal representatives, the entire right, title and interest of the Hired Parties in and throughout the United States of America, its territories and all foreign countries, in and to all inventions as described in the Patent Applications, together with the entire right, title and interest in and to said Patent Applications and any patents as may issue thereon, and any reissue, continuation, continuation-in-part, divisional and foreign counterparts thereof and including the right to claim priority under any applicable statute, treaty or convention based on said Patent Applications; said inventions, applications and patents to be held and enjoyed by said ASSIGNEE for its own use and behalf and for its successors, assigns and legal representatives, to the full end of the term for which any said patents may be granted; the Hired Parties also confirm that they have conveyed and hereby convey all rights arising under or pursuant to any and all international agreements, treaties or laws relating to the protection of industrial property by filing any such applications for patents, all choses in action pertaining to the Patent Applications or patents including the right to sue for and collect damages and other recoveries for past infringement thereof, all rights to initiate proceedings before government and administrative bodies, and all files, records and other materials arising from the prosecution, exploitation, or defense of rights and registrations pertaining to the Patent Applications or patents. The Hired Parties hereby acknowledge that this Confirmatory Assignment, being of their entire right, title and interest in and to said inventions, confirms that ASSIGNEE has all rights necessary to apply for and obtain from competent authorities in all countries of the world any and all Patent Applications or patents by attorneys and agents of ASSIGNEE'S selection and the right to procure the grant of all such Patent

Applications or patents to ASSIGNEE for its own name as assignee of the entire right, title and interest therein;

AND, the Hired Parties hereby agree for themselves and their executors and administrators to execute upon request any other lawful documents and likewise to perform any other lawful acts which may be deemed necessary to secure fully the aforesaid inventions and intellectual property rights to said ASSIGNEE, its successors, assigns and legal representatives, including the execution of applications for patents in foreign countries, and the execution of substitution, reissue, divisional, continuation or continuation-in-part applications and preliminary or other statements and the giving of testimony in any interference or other proceeding in which said inventions or any Patent Applications or patents directed thereto may be involved;


