TUBULAR CHOKED WAVEGUIDE APPLICATOR

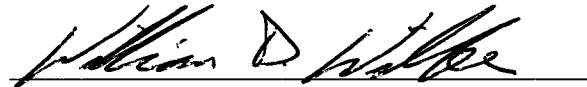

reissued, reexamined, or extended patents of the United States and of any and all foreign countries for the invention, in enforcing any rights accruing from the patent applications or patents by executing preliminary statements and other affidavits and declarations.

- f. I acknowledge that this agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties.

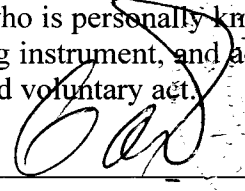
