## GUIDEWORKS PATENTS ASSIGNMENT AGREEMENT

THIS GUIDEWORKS PATENTS ASSIGNMENT AGREEMENT (this "**Assignment**") is dated February 26, 2010, by and between Guideworks, LLC, (f/k/a IPG/JV, LLC) a Delaware limited liability company ("**Seller**") and Rovi Guides, Inc. , a Delaware Corporation ("**Buyer**"). As used herein, each of Seller and Buyer may sometimes be individually referred to as a "**Party**" or collectively referred to as the "**Parties**." Unless otherwise defined herein all capitalized terms shall have the meaning ascribed thereto in the Master Agreement (as defined below).

WHEREAS, pursuant to a Master Agreement executed and delivered contemporaneously with the execution of this Assignment by, among others, Buyer and Seller (the "**Master Agreement**"), the Parties have agreed to enter into this Assignment whereby Seller would sell, transfer and convey its entire right, title and interest in, to and under all patents and patent applications owned by Seller as of the Closing Date (the "**Guideworks Patents**"), including, without limitation, the patents and patent applications set forth on Schedule A, to Buyer, subject to Seller receiving a license from Buyer to such Guideworks Patents pursuant to the terms and conditions of the Transaction Documents (including without limitation the Amended and Restated License and Distribution Agreement).

NOW, THEREFORE, for good and valuable consideration (including the mutual promises and other consideration set forth herein and the other Transaction Documents), the receipt and sufficiency of which is hereby acknowledged by both Parties, the Parties agree as follows:

Section 1.01. *Transfer Of Guideworks Patents.* Subject to the terms and conditions of the Transaction Documents (including without limitation the license to Buyer set forth in the Amended and Restated License and Distribution Agreement), Seller hereby sells, assigns and transfers unto Buyer its entire right, title and interest in and to the Guideworks Patents including all rights to sue for any past, present or future infringement of any such Guideworks Patent. Seller hereby agrees to sign all necessary papers and do all lawful acts reasonably necessary (in each case at Buyer's expense) to effect the sale, assignment and transfer of Seller's entire right, title and interest in the Guideworks Patents.

Section 1.02. *No Warranties or Indemnities.* The Parties agree that the Guideworks Patents are sold, assigned and transferred unto Buyer on an "as-is" basis and Seller (a) makes no representations or warranties (express or implied), (b) grants no indemnities (express or implied) and (c) shall have no other liability or financial obligation to Buyer or any other Person, in the case of (a), (b) or (c), with respect to the Guideworks Patents or otherwise in connection with this Assignment.

Section 1.03. *Governmental Authorities.* Seller hereby authorizes the Governmental Authorities of all countries in which the Guideworks Patents are now or will in the future be issued to issue to Buyer all of Seller's entire right, title and interest in and to the Guideworks Patents for the sole use and enjoyment of Buyer, its successors and assigns (it being understood that, notwithstanding the foregoing, nothing herein shall be construed as limiting in any way the rights granted to Seller in respect of such Guideworks Patents pursuant to the Transaction Documents (including without limitation the Amended and Restated License and Distribution Agreement)).

Section 1.04. *Governing Law.* This Assignment shall be governed by, and construed under the Laws of the State of New York and without regard to conflicts of Laws principles.

Section 1.05. *Venue.* Any dispute arising under or out of this Assignment shall be venued exclusively in the state or federal courts of the State of New York.

Section 1.06. *Counterparts; Effectiveness.* This Assignment may be signed in any number of counterparts, each of which shall be deemed an original. This Assignment shall become effective only after and subject to each Party having received a counterpart hereof signed by the other Party.

Section 1.07. *Successors.* This Assignment shall inure to the benefit of and is binding upon the respective successors and assigns of Seller and Buyer.
