

NOTICE OF GRANT OF SECURITY INTEREST IN PATENTS, dated as of October 17, 2014, by the entity listed on the signature pages hereof ("<u>Grantor</u>"), in favor of NATIONAL BANK OF CANADA in its capacity as administrative agent pursuant to the Credit Agreement referred to below (in such capacity, the "<u>Administrative Agent</u>") (this "<u>Notice</u>").
