





HAIRSETTER

Be it known that we, Genaro Diaz Lozano, and Alonso Hidalgo Luengas, have invented a certain novel, original and ornamental design for a hairsetter, of which the following drawings form part of the specification.

DESCRIPTION OF FIGURES OF THE DRAWINGS

FIG. 1 is a top perspective view of a hairsetter our new design with the electrical cord and top access area illustrated in broken lines;

FIG. 2 is a bottom perspective view thereof;

FIG. 3 is a top elevational view thereof;

FIG. 4 is a bottom elevational view thereof;

FIG. 5 is a left elevational view thereof;

FIG. 6 is a right elevational view thereof;

FIG. 7 is a front elevational view thereof; and

FIG. 8 is a back elevational view thereof.

The broken lines in Figures 1 through 8 are to illustrate an exemplary access area and part of an electrical cord that form no part of the claimed design.

The ornamental design for a hairsetter, as shown and described.

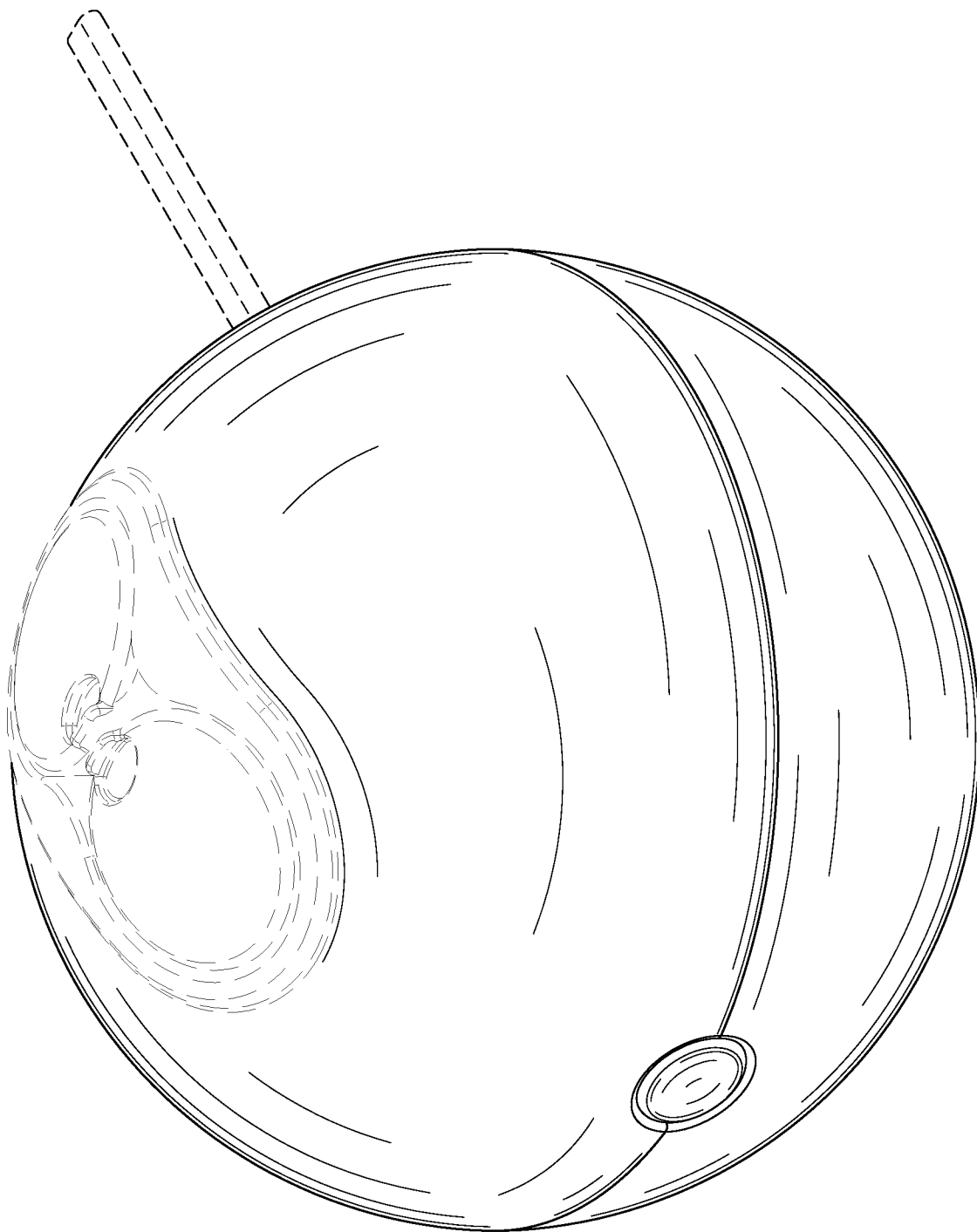

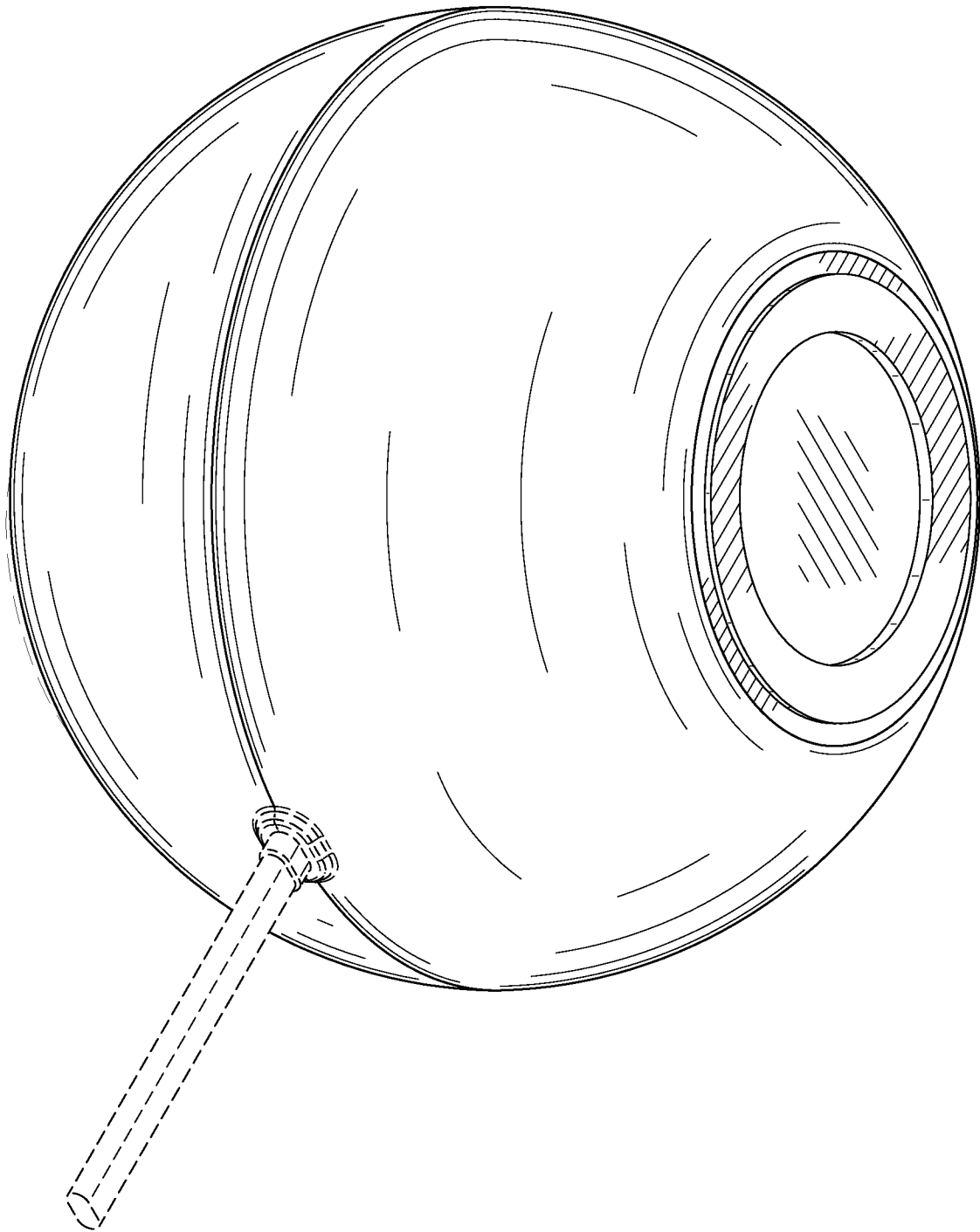

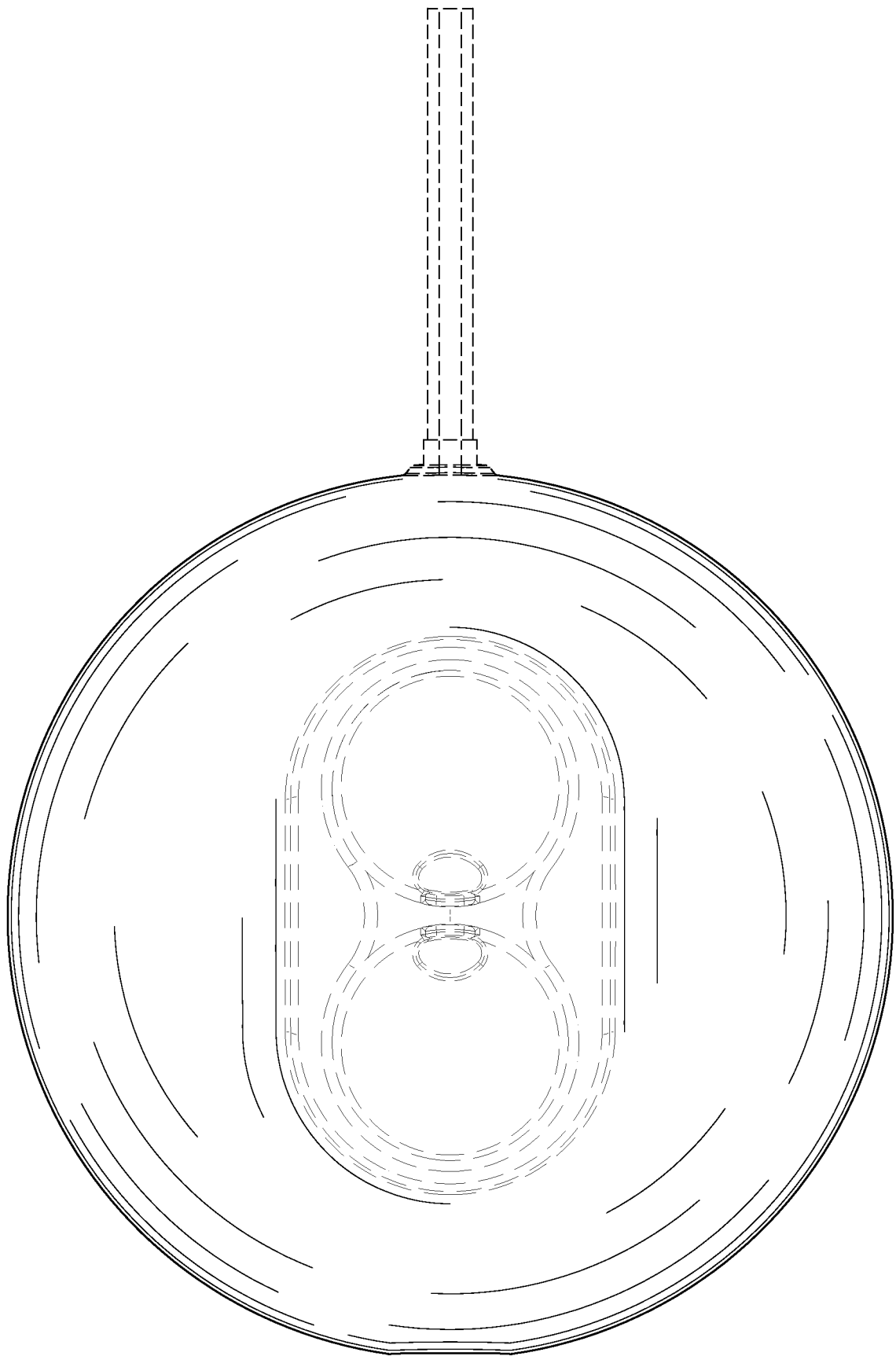

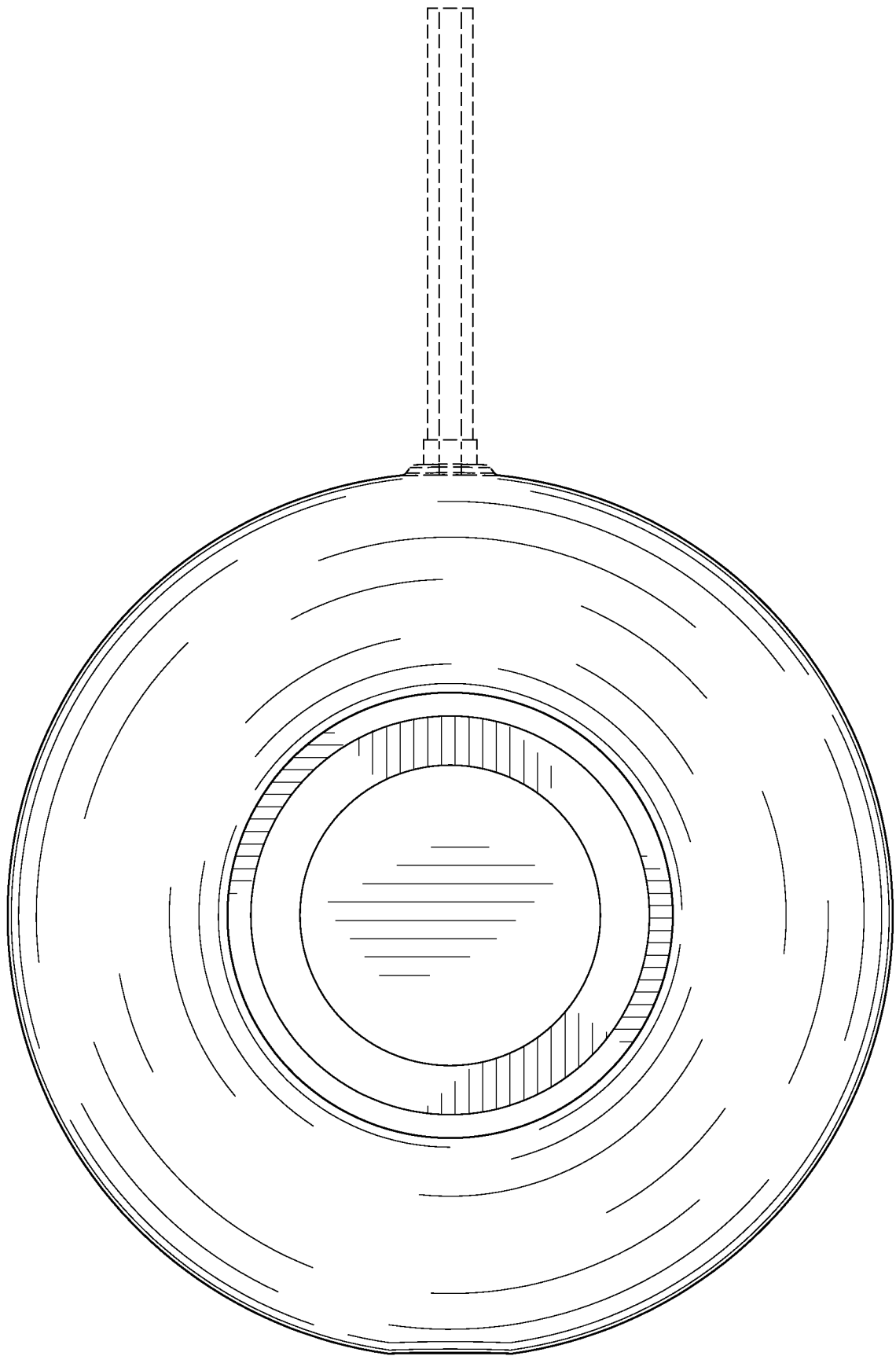

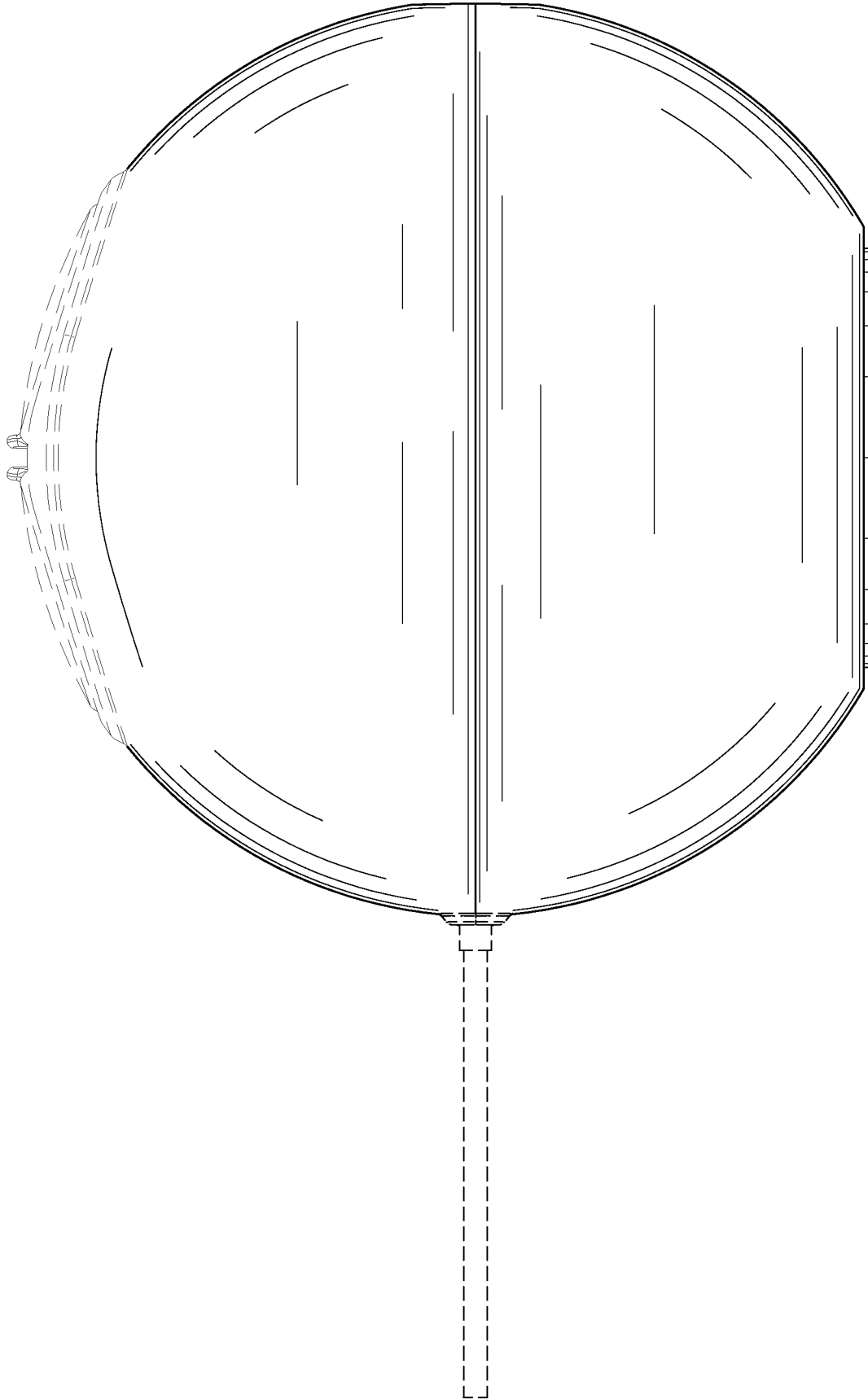

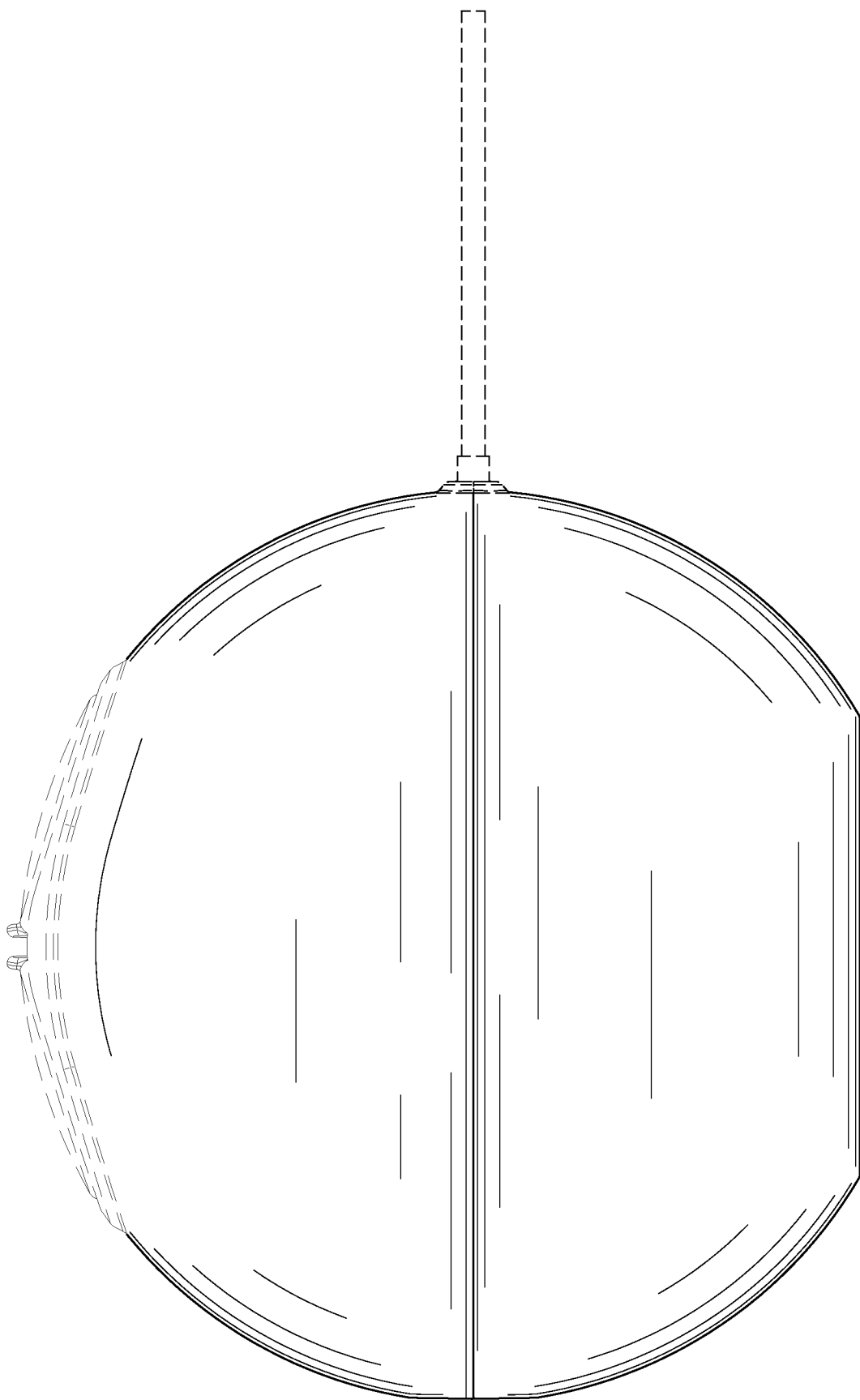

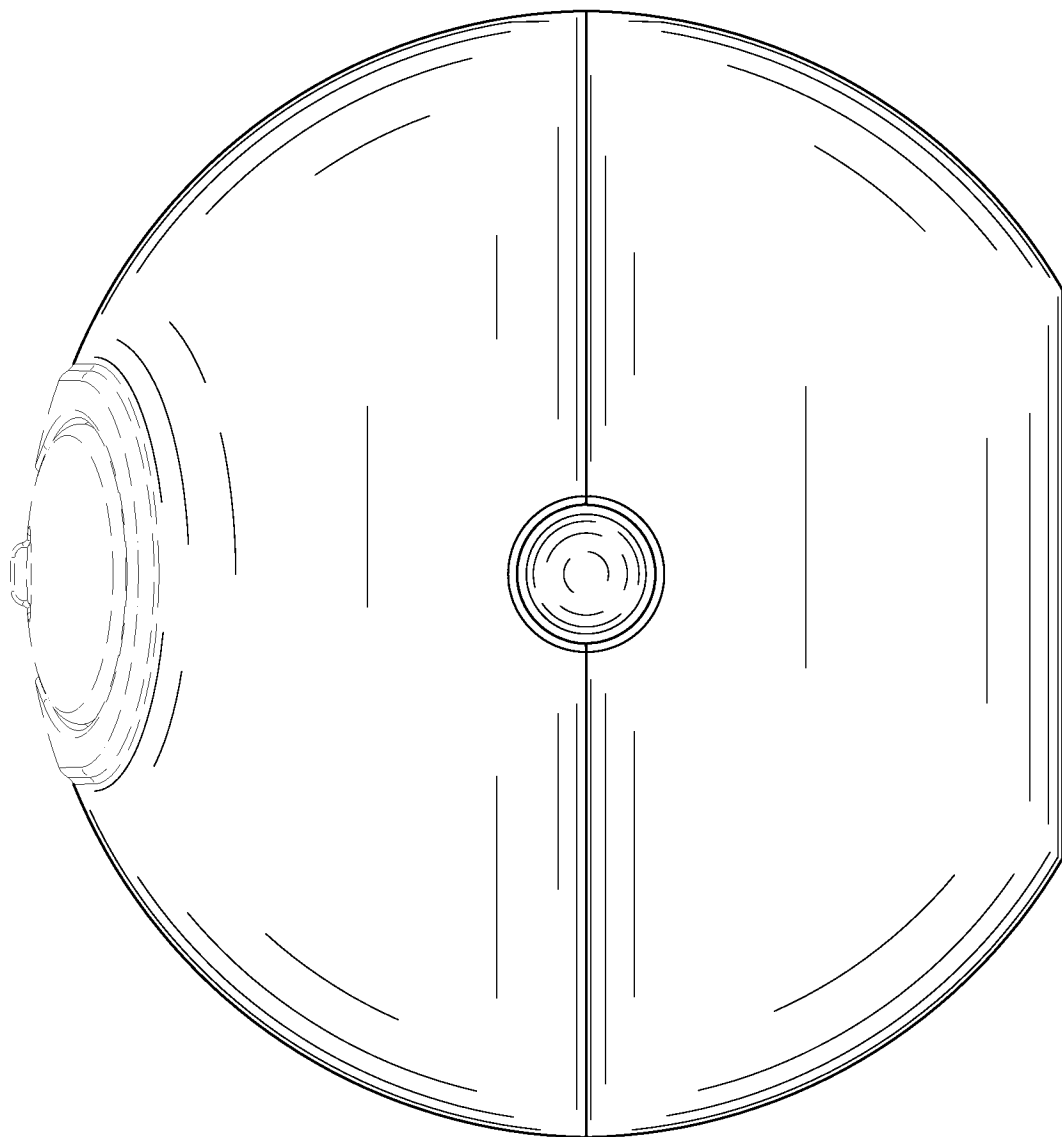

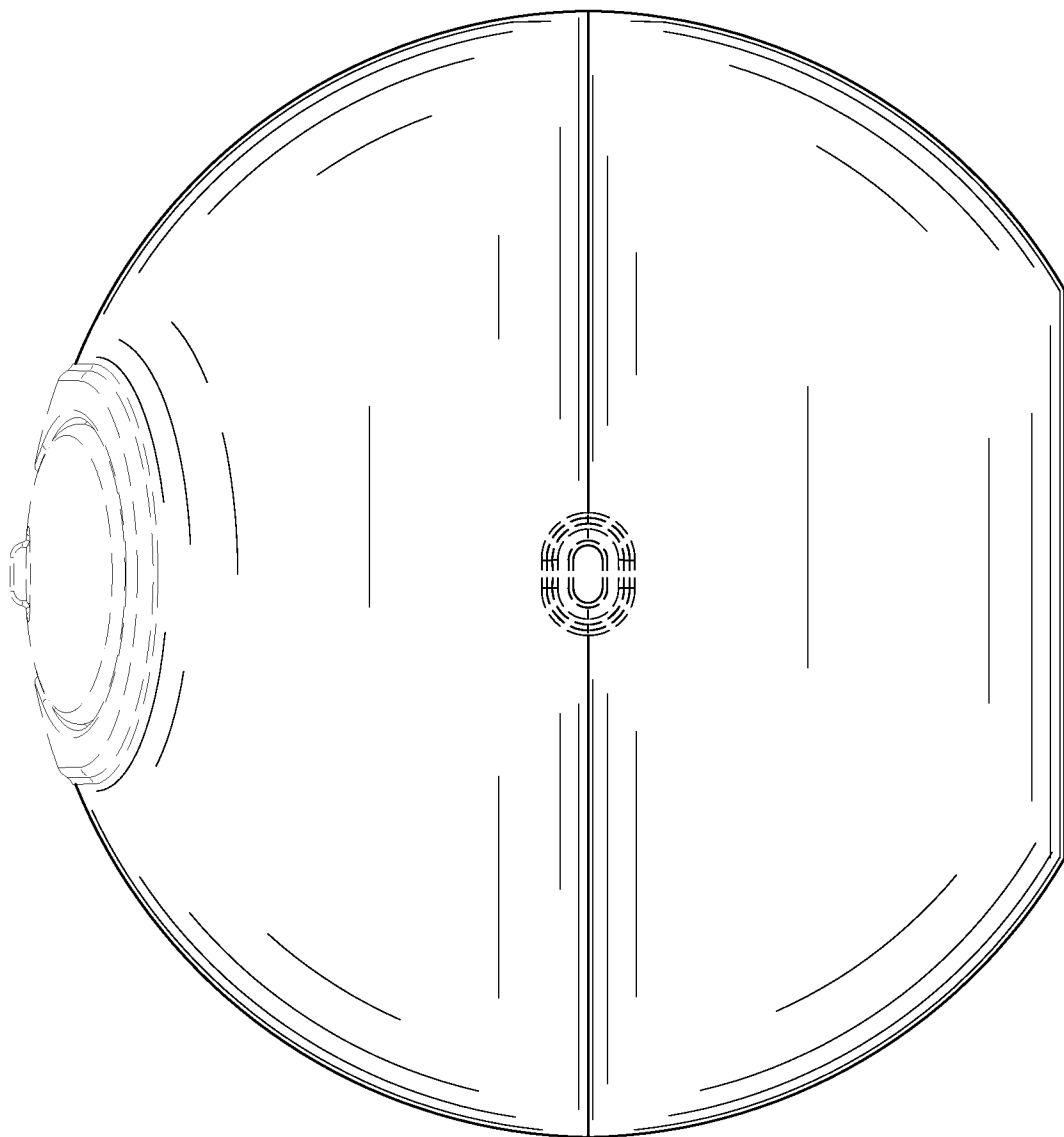
