RELEASE OF PATENT SECURITY INTEREST

(Griffin Technology, Inc.)

THIS RELEASE OF PATENT SECURITY INTEREST (the "Release") is made effective as of August 18, 2014, by SUNTRUST BANK, as Administrative Agent (the "Administrative Agent") to GRIFFIN TECHNOLOGY, INC. (the "Grantor") as follows:

WHEREAS, the Grantor, certain Subsidiaries of the Grantor, and the Administrative Agent are parties to that certain Third Amended and Restated Security Agreement dated as of December 17, 2013 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") executed in order to secure the prompt and complete payment, observance and performance of all of the Secured Obligations in accordance with the terms and conditions of the various loan documents;

WHEREAS, pursuant to, and in connection with, the Security Agreement, the Grantor granted to the Administrative Agent on behalf of the holders of the Secured Obligations, among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under the United States Patents listed on the attached Schedule A (the "Patents");

WHEREAS, in connection with, and in furtherance of, the granting of a security interest in the Patents, the Grantor has previously executed and delivered to the Administrative Agent (a) that certain Patent Security Agreement dated as of December 16, 2008 (as recorded with the U.S. Patent & Trademark Office (the "USPTO") on December 16, 2008 at reel 021985, frame 0320), (b) that certain Patent Security Agreement dated as of November 9, 2011 (as recorded with the USPTO on November 11, 2011 at reel 027220, frame 0181), (c) that certain Patent Security Agreement dated as of December 17, 2013 (as recorded with the USPTO on November 11, 2011 at reel 031895, frame 0655), and (d) that certain Notice of Patent Security Interest dated as of May 1, 2014 (as recorded with the USPTO on May 6, 2014 at reel 032827, frame 0658), for purposes of filing with the United States Patent and Trademark Office; and

WHEREAS, the Administrative Agent wishes to release its security interest in the Patents.

NOW THEREFORE, as the Grantor has satisfied its Secured Obligations under the various loan documents, the Administrative Agent hereby terminates, releases and discharges any security interest in and lien upon the Patents, and assigns, transfers, and conveys to the Grantor any and all right, title or interest in, or to, the Patents that the Administrative Agent may hold.
