ASSIGNMENT OF PATENT RIGHTS

NOW, THEREFORE, for and in consideration of One Dollar (\$1.00) and other good and valuable consideration to ASSIGNOR, the receipt of which is hereby acknowledged, ASSIGNOR has sold, assigned, transferred and set over, and by these presents do sell, assign, transfer and set over unto said ASSIGNEE whatever rights, titles and interests they own in and to the PATENT RIGHTS, and any and all other applications for Letters Patent on said inventions in the United States and in countries foreign to the United States, including all divisional, renewal, substitute, continuation and Convention applications based in whole or in part upon said inventions or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said application and said Letters Patent; said assignee being hereby authorized to file patent applications in any or all countries in any or all said inventions in the name of the undersigned or in the name of said assignee or otherwise as said assignee may deem advisable, under the International Convention or otherwise; the Commissioner of Patents of the United States of America and the empowered officials of all other governments being hereby authorized to issue or transfer all said Letters Patent to said assigned in accordance herewith; this assignment being under covenant, not only that full power to make the same is had by the undersigned, but also that such assigned right in not encumbered by any grant, license, or other right heretofore given, and that the undersigned will do all acts reasonably serving to assure that the said inventions, patent applications and Letters Patent shall be held and enjoyed by the undersigned if this assignment had not been made, and particularly to execute and deliver to said assignee all lawful documents including petitions, specifications, oaths, assignments, invention disclaimers, and lawful affidavits in form and in substance

which may be requested by said assignee, to furnish said assignee with all facts relating to said inventions or the history thereof and any and all documents, photographs, models, samples or other physical exhibits which may be useful for establishing the facts of conception, disclosure and reduction to practice of said inventions, and to testify in any proceedings relating to said inventions, patent applications and Letter Patent.
