**PATENT ASSIGNMENT**

**THIS PATENT ASSIGNMENT** (this “*Assignment*”) is entered into and made effective this 8th day of July, 2013, by and between NeurogesX, Inc., a Delaware corporation (“*Assignor*”), and Acorda Therapeutics, Inc., a Delaware corporation (“*Assignee*”).

**WHEREAS**, Assignor and Assignee are parties to that certain Asset Purchase Agreement dated as of April 15, 2013 (the “*Purchase Agreement*”) pursuant to which Assignor is transferring certain assets and liabilities of Assignor to Assignee; and

**WHEREAS**, the Purchase Agreement contemplates Assignor and Assignee entering into this Assignment in order to effectuate certain of the transfers contemplated by the Purchase Agreement in accordance with the terms and conditions set forth therein and herein.

**NOW, THEREFORE**, in consideration for the execution of the Purchase Agreement, the payment of the consideration stipulated in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignor hereby sells, assigns, transfers and delivers unto Assignee, its successors, legal representatives and assigns, all of Assignor’s rights, title and interests in, to and under the following (the “*Assigned Patents*”): (a) the patents and patent applications identified by title or the U.S., foreign, or international patent or patent application numbers, as applicable, listed on the attached Schedule A and all of the inventions claimed or otherwise disclosed therein (hereafter, collectively, the “*Patents*”), together with all provisionals, non-provisionals, divisions, renewals, requests for continuing examination, continuations, continuations-in-part, substitutions, international counterparts and foreign counterparts thereof in the Buyer Territory (as such term is defined in the Purchase Agreement), and all patents of the United States or of any other country which may be granted thereon in the Buyer Territory, and all reissues, reexaminations, renewals and extensions thereof; (b) all applications for and forms of industrial property protection, including without limitation all applications for patents, utility models, inventors’ certificates and designs which may be filed for any such inventions in the United States and in other countries in the Buyer Territory and all extensions, renewals, re-examinations and reissues thereof; (c) all rights of any kind whatsoever of Assignor accruing under any of the foregoing, including the right to file applications and the right to claim the priority rights or any other rights derived from any patents or patent applications described herein (including without limitation the Patents) under the patent or applicable domestic laws of the United States or any other country in the Buyer Territory, or the Paris Convention for the Protection of Industrial Property, the Patent Cooperation Treaty or any other international agreement, treaty, law or convention.

2. Assignor further sells, assigns, transfers, and delivers to Assignee all of Assignor’s rights to sue or to bring any action or to assert any claim, whether at law or in equity, against any third party relating to any of the Assigned Patents, including without limitation for past, present or future infringement, misappropriation, or other

unauthorized use or misuse of any of the Assigned Patents, to obtain injunctive relief, and to recover or collect royalties, damages, and profits, including without limitation for such past, present or future infringement, misappropriation or unauthorized use or misuse of any of the Assigned Patents.

3. Assignor hereby authorizes and requests the Commissioner for Patents and any official of any country, including without limitation in the United States and in other countries in the Buyer Territory, whose duty it is to issue patents or other evidence or forms of industrial property protection on any applications described herein, to issue the same to the Assignee, its successors, legal representatives and assigns, in accordance with the terms of this Assignment.

4. Assignor hereby covenants and agrees that it will not execute any agreement in conflict herewith.

5. Assignor hereby agrees to prepare, execute and deliver, or to cause to be prepared, executed and delivered, to Assignee, at Assignee's expense, such deeds, bills of sale, instruments of assumption, assignments, instruments of recordation, and other instruments, and take such other actions, in addition to those required by this Assignment, as Assignee may reasonably request in order to effect the intent and purposes of this Assignment (including without limitation the implementation and recordation of the transactions contemplated by this Assignment).

6. Assignor hereby irrevocably designates and appoints Assignee and its duly authorized officers and agents as its agents and attorneys in fact, to act for and in its behalf and stead to execute and file any such documents and to do all other lawfully permitted acts to register, evidence or perfect Assignee's rights under this Assignment, including without limitation as required or contemplated by Section 5 hereof or by the Purchase Agreement, with the same legal force and effect as if executed by Assignor or any of its successors, legal representatives or assigns.

7. Nothing in this Assignment, express or implied, is intended to or shall be construed to modify, expand or limit in any way the terms of the Purchase Agreement. To the extent that any provision of this Assignment conflicts or is inconsistent with the terms of the Purchase Agreement, the terms of the Purchase Agreement shall govern and control.
