ASSIGNMENT

WHEREAS R.F. INNOVATION INC., a legal person, whose full post office address is 288 Bonin Street, Acton Vale, Quebec, J0H 1A0, Canada, acquired by assignment the entire right, title and interest in, to and under:

Inclusive of any and all priority rights derived therefrom and in and to all Letters Patent of Canada, the United States and countries foreign thereto, to be granted for the said invention;

WHEREAS MÉTALLITECH INC., a legal person, whose full post office address is 288 Bonin Street, Acton Vale, Quebec, J0H 1A0, Canada, obtained, on August 27, 2014, judgment before the Superior Court of the Province of Québec, Canada, which order to R.F. Innovation Inc. to surrender in favour of Métallitech Inc. the entire right, title and interest in, to and under the said Inventions and the said Patent and Application therefor, inclusive of any and all priority rights derived therefrom and in and to all Letters Patent of Canada, the United States and countries foreign thereto, to be granted for the said invention;

NOW, THEREFORE, in consideration of the hereinabove mentioned judgment and in order to comply with this judgment, R.F. Innovation Inc., (hereinafter called the «Assignor») does hereby surrender, assign and set over unto Métallitech Inc. (hereinafter called the «Assignee»), its entire right, title and interest in Canada, the United States and all other countries in and to the said Patent and Application in and to the said Inventions disclosed therein, inclusive of any and all priority rights derived therefrom, the same to be held and enjoyed by the Assignee, its successors, assigns or legal representatives to the full ends of the terms for which all Letters Patent therefor may be granted, including any extensions or renewals thereof, as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and sale had not been made;

AND R.F. INNOVATION INC. HEREBY AUTHORIZE the Assignee to make application for and to receive Letters Patent for said Inventions in any foreign countries in its own name or in any name at its election.

AND R.F. INNOVATION INC. HEREBY COVENANT AND AGREE to execute or to procure any further necessary assurance of the title to the said Inventions and Letters Patent and that it will, at any time upon the request and at the expense of the Assignee, execute and deliver any and all papers that may be necessary or desirable to perfect the title to said Inventions or any Letters Patent which may be granted therefore to the Assignee, its successors, assigns, or other legal representatives and that the Assignor's representatives will, at any time upon the request and at the expense of the Assignee, testify in any legal proceedings, sign all lawful papers, execute any additional divisional, substituting, continuing or reissuing applications for patents for said invention or any part or parts thereof, make all rightful oaths and generally do all lawful acts to aid the Assignee, its successors, assigns or other legal representatives to obtain and enforce patent protection in said inventions in all countries, without further compensation but at the expense of the Assignee, its successors, assigns or other legal representatives.

AND R.F. INNOVATION INC. HEREBY AUTHORIZE AND REQUEST the Commissioner of Patents or the Comptroller (as the case may be) to issue any and all Letters Patent for said Inventions or resulting from said Application or from any division, reissue or extensions thereof to the Assignee as sole Assignee.
